1. I hereby give my consent for my dog to be admitted for Daycare services, and to participate and be involved in activities at Debbie's Downtown Doggie Daycare LLC.
2. I further understand that Debbie's Downtown Doggie Daycare LLC has relied upon my representation that my dog is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog for services at their facility.
3. I further understand that Debbie's Downtown Doggie Daycare LLC, its owners, staff, employees and volunteers, will not be liable, financially or otherwise for any injuries or damages sustained by my dog, myself, or any property of mine while my dog is on the premises of, under the care of, receiving services from or participating in any services provided by Debbie's Downtown Doggie Daycare LLC. I hereby release, acquit, Debbie's Downtown Doggie Daycare LLC, its owner, staff, employees and volunteers of any and all liability of any kind arising from my dog's participation in any and all services or activities provided by Debbie's Downtown Doggie Daycare LLC.
4. I further understand that I am solely responsible, financially or otherwise, for any and all injury, harm, or damage caused by and/or in any way related to my dog activities while my dog is receiving services, or engaging in any activities provided by Debbie's Downtown Doggie Daycare LLC.
5. I further understand and agree that any problems with my dog, behavioral, medical or otherwise will be treated as deemed best by staff of Debbie's Downtown Doggie Daycare LLC in their sole discretion, and what they view as the best interest of the animal. I understand that I assume full financial responsibility and liability for any and all expenses involved in regards to the behavior and health of my dog.

- 6 I further understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by Debbie's Downtown Doggie Daycare LLC and while in their care. I understand that while the socialization and play is closely and carefully monitored by Debbie's Downtown Doggie Daycare LLC staff to prevent injury, it is still possible that during the course of normal play, my dog may receive minor nicks and scratches from roughhousing with other dogs. Any injuries to my dogs will be pointed out by staff upon pick-up.
- 7 I further understand by allowing my dog to participate in services offered by Debbie's Downtown Doggie Daycare LLC. I hereby agree to allow Debbie's Downtown Doggie Daycare LLC. to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
- 8 I further understand that in the event my dog is not picked up on time, I hereby authorize Debbie's Downtown Doggie Daycare LLC. to take whatever action is deemed necessary for the continuing care of my dog. I will pay Debbie's Downtown Doggie Daycare LLC. the cost of any such continuing care upon demand by Debbie's Downtown Doggie Daycare LLC. I understand that if I do not pick up my animal, Debbie's Downtown Doggie Daycare LLC. will proceed according to the guidelines provided by Pennsylvania Statutes Title 3 P.S. Agriculture § 459-601 § 459-601 - abandonment of animals by owner. I also acknowledge that I will be fully responsible for all attorney's fees and associated costs if I abandon my dog.
- 9 I further understand I will maintain current vaccinations and furnish veterinarian records as they are updated to Debbie's Downtown Doggie Daycare LLC.
- 10 I further understand that my dog must be leashed in and out of the building.
- 11 I further understand that if Debbie's Downtown Doggie Daycare LLC deems that my dog's nails are too long and may be a danger, Debbie's Downtown Doggie Daycare LLC will trim my dog's nails without prior notification and at my expense.
- 12 I further understand that if I've booked an appointment for daycare and need to cancel, I need to call by 7:10 am that day, at the latest. If we are booked and you're a no show and I have to turn a dog away, you will be charged for a full day.
- 13 If you are late to pick up, you will be charged one dollar for each minute you are late, starting at 5:31
